



## Purchase conditions

Dear clients,

Please note our conditions for the purchase of empty printer cartridges:

### Purchase prices

We always purchase at the conditions of the current purchase [price list](#). The compensation amount depends on the current purchase price list which is valid when the empty printer cartridges arrive. The purchase prices are always adjusted to the market value and can fluctuate many times a year. All indicated purchase prices are given in Euro.

### Delivery

The delivery of the goods should take place as "free house", which means that all incurred transport costs must first be taken over by the customer. Starting at a compensation value of 30 euros, we will refund you the shipping cost. For this you should always attach the postage voucher (postal service, DHL proof) to the package. For larger quantities, please contact us by phone.

### Compensation

Upon receipt, the empty toners and inks are subjected to a quantitative and qualitative receipt inspection by our qualified personnel. The payment is carried out after completion of the inspection of goods. In addition, we will send you an e-mail with the exact listing of your goods. A settlement with current or future claims between the co. Denner to the customer is excluded.

### Packaging

The empty printer cartridges must be properly packed. It is best to package each toner cartridge individually in the black PE original film or another bag. Cartridges or ink cartridges, where residual filling material emerges, please pack separately in plastic bags. We ask you to abstain from styrofoam or cornflips during packaging and recommend newspaper as filling material. The sender is liable for damage caused by improper packaging.

### Delivery note

Each consignment with empty inks or toners must be accompanied by the delivery note with your address data, your e-mail address, your telephone number and your bank details. For delays due to missing information, co. Denner assumes no liability. A listing of the content is not required.

## Defective empty printer cartridges

Only valid and fully functional toner cartridges and ink cartridges listed on the applicable purchase price list will be reimbursed.

## Non-recyclable printer cartridges

Ink cartridges not listed on our purchase price list will be disposed free of charge. Shipments that are excessively soiled through toner or inks are not compensated by spilled toner.

## Empties recycling dealers, bulk quantities

We buy from commercial end users, associations, public institutions, IT retailers and private individuals. For recycling and empty traders, this list is only valid if you set up a prior arrangement with us. Deliveries of recyclers and resellers must be announced in writing in advance and require our confirmation of purchase.

## Collection boxes for empty printer cartridges

Collection boxes, empties boxes, or pallet boxes provided by the co. Denner are exclusively for collecting used toner cartridges and ink cartridges. You can request a collection box from us at any time. The collection boxes, empties boxes, pallet boxes and their contents remain the property of co. Denner. In case of loss or damage, we charge a fee of 4.00 € plus VAT per lost or damaged collection box.

## Final determination

Only the general terms and conditions of the co. Denner apply, even if we have not expressly objected to other terms and conditions. By submitting the empty printer cartridges, you automatically accept the terms and conditions of the co. Denner, which are always available on the Internet at [www.abfallbringtgeld.at](http://www.abfallbringtgeld.at).

Both, the sending of goods to us and the issue of a collection order are merely offer's to conclude a contract. The conclusion of a contract requires in any case the acceptance by us. We expressly and clarify the right to refuse offers submitted by us to conclude a contract to anyone without giving reasons. Should individual provisions of these terms and conditions be or become invalid, this shall not affect the validity of the remaining provisions.
